- 1. By way of Law 4490/2017 (the **Law**) Greece ratified the Multilateral Competent Authority Agreement on the exchange of Country-by-Country Reports (**CbC**).
- 2. In compliance with the Law, the Independent Authority of Public Revenues (IAPR) issued Decision A. 1083/2014 (Decision), listing the countries participating in the mutual exchange of the CbC Reports for the 2022 tax year, as such reports will be exchanged in the 2024 tax year.
